RULES FOR CREATION AND UTILISATION OF PUNJAB STATE COOPERATIVE SOCIETIES DEVELOPMENT FUND.

These rules shall be called 'Punjab State Cooperative Societies Development ind Rules, 1994.

These rules shall come into force from the date of approval of Registrar, poperative Societies, Punjab as per provision of Section 42 of Punjab Cooperative ocieties Act. 1961.

SHORT TITLE

Punjab State Cooperative Societies Development Fund rules1994 as per ovision of section 42 of Punjab Cooperative Societies Act, 1961.

DEFINITION

- 1) "RCS'means Registrar, Cooperative Societies Punjab.
- "Fund" means" Punjab State Cooperative Societies Development Fund. ii)
- "Committee" means Managing Committee constituted under these rules. iii)
- "Act" means Punjab, Cooperative Societies, Act, 1961. iv)
- "Rules" means Punjab Cooperative Societies, rules, 1963. V)
- "Words and expressions defined in the Act and rules and used in these rules shall have the Meanings, respectively, assigned to them in the Act.

OBJECTS OF THE FUND

This fund shall be established and maintained for the purpose of economic development of Cooperative Societies in the State especially for the follwing purposes : -

- a) In order to help the weak Cooperative Societies in the State especially those societies which are suffering for want of financial assistance. The financial assistance to these societies shall be given in the form of short term, medium term and long term loans at the terms and conditions to be decided by the committee.
- To undertake any such scheme for the economic development of Cooperative Societies in the State.
- c) To undertake all such other measures as are incidental or conducive to the attainment of the objects mentioned above.

4. MEMBERSHIP

All apex and central cooperative societies of the State as notified by the R.C.S. from time to time, shall be the members of the fund for the purpose of contributions.

5. METHOD OF RAISING THE RESOURCES FOR THE FUND.

- All member societies, after 1/10th the net profits in any year has been carried to the Reserve Fund, shall contribute an amount not exceeding 5% of the remaining net profits to the fund.
- iii) Any Central, Primary or Apex Cooperative, Society in the State shall be at liberity to contribute any sum over and above as prescribed at (i) above to the fund.

The Fund shall be open for subscription intially for a period of 5 years from the date of notification issued in this regard by Registrar, Cooperative Societies, Punjab.

6. MAINTENANCE OF ACCOUNT OF THE FUND.

The sum collected shall be deposited in Punjab State Cooperative Bank in an account opened in the name of Punjab State Cooperative Societies Development Fund. 1994.

7. MANAGEMENT OF THE FUND.

The fund shall be managed by a committee consisting of all the Chief Executive Officers of Apex Cooperative Institutions, R.C.S. Punjab shall be the Ex-Officio Chairman of the Managing Committee.

Chief Executive Officer of Punjab State Cooperative Bank shall be Secretary of the committee.

Any 3 members shall form the quorum for the meeting. Punjab State Cooperative Bank shall provide necessary Secretarial Services for the fund.
