Guidelines for Creation and Liquidation of the Subject: Primary Cooperative Societies Vikas Fund

The Primary Cooperative Societies are the foundation, on which gyramid of Cooperatives is buil. These Societies provide sustenance and constitute network for marketing and development of products of the Central and Apex Cooperative Institutions. In many cases, the success of Apex and Central Cooperative Institutions depends on the success and strength of rimary Cooperative Societies. In view of these basic considerations, it has mean decided to create the Primary Cooperative Societies Vikas Fund vide the Registrar, Poperative Societies, Punjab under Rule 45 of the Punjab Cooperative Societies Rules 1963

to order to ensure that Primary Cooperative Societies Vikas Fund so created is utilised fairly and properly, the following guidelines are circulated for creation and utilisation of the fund:

## Objectives of the Fund

- The objectives of the fund should be: 2.1
  - to strengthen and sustain the infrastructure of the Primary Cooperative Societies;
  - to provide for and reduce imbalances in the Primary Cooperative 11)
  - to help the Primary Cooperative Societies in taking up new income generating activities and other measures for the benefit in of their members; and
  - to undertake any other steps are incidental or conducive to the (vi attainment of the above objectives.

## Creation and Utilisation of the Fund

- All Apex and Central Cooperative Societies should create the Primary Cooperative Societies Vikas Fund in accordance with i) 2.2 the instructions issued by the Registrar, Cooperative Societies from time to time;
  - The fund should be utilised by all Apex and Central Cooperatives for the benefit of the Primary Cooperative 11) Societies, which may be their members of the members of those Central Cooperative Societies, which are the members of the Apex Cooperatives concerned for the above said objects; and
  - The fund should be utilised by all Apex and Central Cooperatives with the approval of the Board of Directors / ·iii) Administrator or sub-Committee constituted, if any, for the purpose.

## Maintenance of Accounts of the Fund

The Primary Cooperative Societies Vikes Fund of all Apex and Central Cooperatives should be deposited with the Punjab State Cooperative Bank / Central Cooperative Banks in an account of the said Apex and Central Cooperatives, especially designated for the purpose; and

The annual accounts of the fund should be placed before the General Body of these Societies along with their annual financial accounts.

A ,

- The general provisions of the Punjab Cooperative Societies Act. 1961 and Rules framed thereunder should apply as per <u>General</u> delegation thereof to the officers of the Department of Cooperation, Punjab for implementation of the above guidelines.
  - In case any difficulty arises in giving effect to these guidelines, the matter may be referred to the Registrar, Cooperative Societies for clarification / modification as the case may be. ii)
  - All Apex and Central Cooperative Societies should keep these guidelines in view while creating and utilising the Primary Cooperative Societies Vikas Fund.
