ORDER

In partial modification of this office order issued vide endst.No. RCS/E&T/ EI/ 10/66-A dated 10.8.11 vide which various departmental officers were authorized to adjudicate court cases under sections 54,56,68 and 69 of the Punjab Cooperative Societies Act, 1961, the following norms are refixed .

Sr.No.	Designation	Principal Amount involved in the dispute in Rupees
1.	Inspector Cooperative Societies	Upto 5.00 lacs
2.	Assistant Registrars, Cooperative Societies	Above 5.00 lacs and upto 15.00 lacs
3.	Deputy Registrars, Cooperative Societies	Above 15.00 lacs and upto 50.00 lacs
4.	Joint Registrars, Cooperative Societies	Above 50.00 lacs and upto 1.00 Crore

2. The norms for Additional Registrar, Cooperative Societies and the Registrar, Cooperative Societies, Punjab, Chandigarh shall remain the unchanged. The norms for them are reproduced below for ready reference.

1	Addl. Registrars, Cooperative Societies	<ol style="list-style-type: none"> For court cases of Cooperative Institutions other than Markfed above Rs. 1.00 Crore and upto 2.00 Crores For court cases relating to Markfed above Rs. 1.00 Crore and upto Rs. 10.00 Crores
2.	Registrar, Cooperative Societies, Punjab, Chandigarh.	<ol style="list-style-type: none"> For court cases of Cooperative Institutions other than Markfed above Rs. 2.00 Crores For court cases relating to Markfed above Rs. 10.00 Crores

3. Further , the Registrar, Cooperative Societies, Punjab , Chandigarh reserves the right to mark any court case involving any amount to any officer for adjudication . These orders are issued in exercise of the powers vested in the Registrar, Cooperative Societies, Punjab , Chandigarh under sections 54,56,68 and 69 of the Punjab Cooperative Societies Act, 1961.
